Letter from Paul Suffoletto, President, Teamsters Local Union No. 284, Columbus, Ohio – August 21, 2015

Dear Brother Stan Hennessy:

On behalf of all the members of Teamsters Local 284, and more specifically the workers at Heidelberg Distributing in Columbus, Ohio I would like to thank you for your support for their fight for a first Teamsters contract.

It has been a struggle of more than 2 ½ years since the workers at Heidelberg voted to have Local 284 represent them. We faced off against the company's union busting attorney for quite a long time with very little movement towards a tentative agreement until we put together a plan with the IBT Strategic Research & Campaigns Department.

Slowly as pressure began to build against the company, they started to budge and when you and our brothers from Local 31 leafleted the World Cup Soccer game in Vancouver with Labatt fliers, it really helped push things over the top! It was obvious the company was concerned when the corporate campaign against them spread internationally with your approval and help. All of a sudden talks started to move towards a settlement. The company mentioned over and over again they wanted the corporate campaign to stop.

We did reach an agreement with the company and the workers ratified the contract overwhelmingly.

During this past year our Organizing Department led by Bro. Ben Hennessy has successfully organized the following companies. USF Reddaway Inc., Seaville Transport Ltd., R&B Trucking Ltd., Canada Cartage (Whitehorse) to name a few, with a number of organizing drives on the go.

The Local has also refurbished our tractor and trailer. The trailer has had a total makeover with a new sound system, lighting and electronics thus enhancing our organizing ability by creating a modern classroom setting that can accommodate fifty people.



## **New Contract Ratified at Coast 2000**

After two months of negotiations, the Local is pleased to report the ratification of a new contract at Coast 2000. The contract will provide stability and growth during the term of the agreement while enhancing wages and benefits to our members.

The elected bargaining committee included Rob Abbott, shop steward, 17-year member; Jas Haer, shop steward, nine-year member; and Larry Sargeant, Business Representative.

The new contract will almost double the amount of pension contributions for Local 31 members at Coast 2000. Additionally, to support the education of our Teamster mechanics, our members will receive an hourly rate while attending class and will be compensated for the purchase of classroom books.

"I would like to thank the bargaining committee for their hard work and help throughout our negotiations and the members for their support," stated Bro. Sargeant "and President Hennessy for speaking to our bargaining committee ensuring that the members received a solid contract."

Coast 2000 is the largest, thirdparty logistics export service provider to the pulp and paper, lumber and marine container industries. Local 31 members proudly perform duties that include receiving products by rail and truck, warehousing and transloading products to containers, handling deep-sea containers using side picks, ABS Certified Mechanic container repair, loading and off-loading of water barges and pre-tripping reefer service.

The Martin Brower Blaze is a high performance sprint team. Initially, we began our team with four co-workers joining up with three of our customer's workers and three sprinters who were unattached, meaning they did not belong to any club or team. Along with the support from our Centre Manager, Dennis Babey, we were able to organize an official Martin Brower Track and Field Club through BC Athletics. www.bcathletics.org

As a member of the Joint Health and Safety Committee, I feel it is important to maintain a healthy active lifestyle, since our work at Martin Brower is physically demanding. Having our own high performance sprint team is an outlet for my co-workers and their families to support our goals of healthy living.

In our first track meet, back in February 2015, we quickly learned that this is a very serious business. By finishing last in our very first race, our team committed to train harder and longer, dedicating at least an hour of time each day and one day a week at a central track focussing largely on relays.

Our sprinters steadily improved throughout the year, continually getting faster with good old fashion hard work. At the 2015 BC Track and Field Championships in Nanaimo, our team finished third in the open relays with Vancouver Thunderbirds (UBC) winning gold, University of Victoria, silver, and the Martin Brower Blaze, bronze.

This was more than expected in our first year as a track club and more importantly, every teammate's fitness levels increased to unexpected levels. It is highly important to note, it was really special when we had our families and Teamster brothers and sisters supporting us at our track meets giving each sprinter the extra edge to reach our goal of winning gold.

The team is really looking forward to the 2016 season, we are growing faster than expected attracting new sprinters of all ages including masters, plus some of the fastest sprinters in the province with Olympic aspirations. Our new Head Coach, Karl Jones was ranked seventh in the world clocking a very fast 0:10:19.

# Robert "Bobby" Smith, Teamsters, Purolator, Prince George

Dear President Stan Hennessy and Teamsters Local 31 Executive Board,

On March 16th, 2015, there was a broadcast on several National News Networks of myself and two other employees tossing parcels and envelopes from a cargo plane into a bag then into the back of a Purolator work truck. The video was captured by via citizen's cell phone while at the Prince George Airport on March 13th.

Two days after the video appeared, all three of us were let go of all duties instantly. I was in shock by this and thought, what do I do next? I filed a grievance and contacted the Union.

From day one, my Union and Business Rep. Anthony Kirk backed me up the entire time. I've never seen or heard of a Union doing such an amazing job.



This was a tough time for me. As I didn't have any income coming in, I didn't have any money to pay my bills or help out in the house. I am thankful enough to have my daughter and son-in-law who were able to help me pay for my bills as they were beginning to pile up very quickly. My truck ended up breaking down and I couldn't afford the thousands of dollars to fix it so I ended up selling it for the price they gave me which wasn't much at all. I started to feel very upset and frustrated as each day

passed without any return calls for a job interview.

The Teamsters filed for arbitration and went above and beyond, fighting everything the company threw at us, making sure that the right thing was done and we won our case.


Now that I am back to work and getting my back pay, I can breathe easier knowing that I have my job back, without losing my seniority, position or my wage. I am very

thankful for the Teamsters and the Teamsters Legal Counsel, David Reynolds who fought hard on my behalf during this whole ordeal.

Now I can get my life back to normal since I have my job back.

# Coquitlam couple celebrate 20 years of volunteering

Ernie and Janet Nial have seen a lot in their 20 years of volunteering at the Share toy donation bin at Coquitlam Centre — stress and panic, certainly, but also patience, gratitude and overwhelming generosity.

For two decades the couple has used two weeks of their annual holiday time to staff shifts at the Share donation booth. They started when their daughters were 10 and 13 and, over the years, got better at juggling their volunteer work in the busy days leading up to Christmas.

It never occurred to them to use those two weeks for a holiday instead, or to do anything but be at the mall at the peak of holiday shopping madness.

"It's amazing, the people that you

meet," Janet said as she wiped away a tear. "Sometimes people come and say they used to get toys from Share as a kid, and now they've turned their lives around and they want to give back."

They see parents with young children, coaxing their little ones to the donation bin as they patiently explain the brand new toy is not for them but, instead, for other kids who aren't so fortunate.

They see how those early lessons resonate when teenagers drop off a donation, because it's what they did as little kids with their parents. And they are struck with awe by those whose generosity defies comprehension, like the elderly man Ernie has twice seen deposit a \$1,500 cheque in the box or the two women who donated \$1,000 in mall gift cards, even though it looked like they needed it more, Janet said.

"It just reminds you that you should never judge people, and that you never know what's gone on in people's lives," she said. Even the small gifts mean a great deal, the couple said, because whether the donation is a toy or money, every little bit helps.

"When you see the joy on the kids' faces," Janet said, "it makes it all worthwhile. It restores your faith in humanity."

## History – Built to Last 1927 Hayes-Anderson

Built in Vancouver and driven by Teamsters

The Local 31 Executive Board vision was to restore and highlight the 1927 Hayes Anderson as a part of our local Teamster history at the many community events the Local volunteers for. The motion moved at a General Membership meeting was carried unanimously by the membership to restore the vintage truck.

Work on restoring the vintage Hayes Anderson began in January 2015 and took six months to complete. The entire truck was pulled apart for repair and stripped to the bare chassis. The mechanics began re-assembling the Hayes truck with original, hand crafted and machined components acquired from throughout Canada and U.S.A.

Proudly, the first event showcasing the newly restored truck shall be the Hats Off Day Parade in Burnaby on June 4th, 2016.

Originally purchased by Comet Delivery from Hayes Anderson in October 1929, A.L. King worked the truck until 1935, after which it was put into storage until it was donated by Mr. King's estate to the B.C. Transportation Museum, and then later the Teamsters Museum.

Teamster retirees preserved the antique with donations from visiting patrons and monies earned from working the truck in Hollywood movies (ie: Legends of the Fall). The remainder of the collection resides in Cloverdale at the BC Vintage Truck Museum. The original 1927 Hayes-Anderson model "F" Flatdeck consisted of a 4 cylinder Continental Engine, 255 cubic inches, 29 h.p. 4 speed transmission. Single-speed rear axle.

Hayes-Anderson was a Vancouver based company established in 1920 by Douglas Hayes, a parts dealer, and partner W. Anderson from Quadra Island, and was originally the Hayes-Anderson Motor Company Ltd. It was renamed Hayes Manufacturing Company Ltd. in 1928 when the company built a large factory on the False Creek flats. The company eventually had over 600 employees and three plants.

The truck hood ornament was a die-cast, chrome-plated, 5-pound bear or a bronze cast bear. The chrome bear was found on the clippers and the bronze was off the square nose logger with butterfly wings. There was also a small bear ornament on each door. Mack Trucks acquired a controlling share in Hayes Manufacturing in 1969. The company was renamed Hayes Trucks in 1971. In 1975, Mack sold the company to Kenworth Paccar, which closed the Hayes plants.

## **Increasing Teamster Strength**



#### **Seaville Transport Logistics Ltd.**

Our new members at Seaville Transport Logistics Ltd. perform container work from Port Metro Vancouver, transporting containers to companies throughout Vancouver and the Fraser Valley. The bargaining unit is made up of 25 company drivers and dependent contractors.

The drivers were seeking to improve their working conditions for some time and displayed courage and steadfastness throughout the entire organizing drive.

Collective bargaing began and soon thereafter the Union filed unfair labour practices at the Canada Industrial Relations Board. The Employer and the Union were able to resolve the issues and agreed to a 14 point settlement.

During the same time period, the Union filed for mediation. At this point, President Stan Hennessy chaired collective bargaining. Both parties could not come to an agreement which resulted in the Union presenting the agreement to the membership, and the membership rejecting the offer and voting in favor of giving the Union a strike mandate.

Shortly thereafter, the Union bargaining committee met with the Employer and negotiated an agreed to contract that was ratified by the membership in December 2015.

Seaville's collective agreement contains Teamster union security, seniority, paid for exams, paid for day of accident, overtime provisions, and a particular clause that specifically reflects the needs of our Port drivers: "an employee may apply for a sixty (60) day leave of absence once every two (2) years for the purpose of international travel".

It is important to recognize that we could not get this job done without the strength of our members at Seaville. Special thanks to our bargaining committee: Bargaining Chair, President Stan Hennessy, elected bargaining member, Harjit Hans, Business Representative Grant Coleman, Business Representative Larry Sargeant and Organizer, Ben Hennessy.

Thank you to our Shop Stewards, Harjit Hans and Tarsem Ghuman for all of your hard work.



#### **USF Reddaway Inc.**

Local 31 won a representation vote that certified the Union at the Provincial Labour Relations Board to represent the drivers, warehouse workers and clerical staff at USF Reddaway Inc. in Delta.

Some 1,600 workers of this company are unionized with the Teamsters throughout the USA. Our workers wanted to be respected by their employer. Local 31 is proud to have given the workers at USF Reddaway a strong, helping Teamsters hand up to build a brighter future.

Business Representative Mike Hennessy was appointed by President Stan Hennessy to bargain a first contract. After three months of negotiations, Bro. Hennessy filed for mediation at the BC Labour Relations Board.

While the Union continued to bargain, it met with the bargaining unit members to discuss the current state of bargaining, and the members voted unanimously in favor of a strike.

Shortly thereafter, USF Reddaway announced to the bargaining committee that the company would be merging with YRC Reimer (another Local 31 company) under the YRC Corporation.

Bro. Hennessy negotiated terms to ensure that all the USF members would be carried into employment under the YRC Reimer collective agreement and that their seniority would be dove-tailed. Furthermore, in January, once the workers were joined as one bargaining unit, members voted to ratify a five year agreement earning increases to wages, pension and vacation time.

On December 14th, 2015 the new YRC Reimer members began their first shift at the Burnaby terminal under a mature Teamsters collective agreement that contained all the proposals that they had originally proposed when the USF workers were newly-organized.

Local 31 thanks the USF members who dedicated themselves to accomplish their goal of bringing respect and dignity to the workplace by joining as Teamsters.

Moreover, thanks to YRC Reimer Shop Steward and Trustee, Jim Kidd and all the YRC Reimer brothers and sisters who welcomed our new members into the Teamsters. Additionally, thanks to David Reynolds, Local 31 Legal Counsel and President Hennessy; their direction and leadership proved to be invaluable.

## **Tips to Get a Scholarship**

#### A Few Words of Advice for the Student by Bernadette Baio

Over the years, I've had the privilege of arranging and organizing many applications in preparation for the next step in the process—that of selection. If I may, I'd like to share some observations I've experienced in the hopes of offering some advice to future candidates.

Make sure your application gets to its destination in plenty of time—don't leave it to the last minute as a late entry will not be accepted.

Ensure that your application is complete and correct in every way. Have others check it—your parents, your counsellors.

Satisfy everything as required;

don't leave anything out. Again, get help from others to ensure you are doing it right.

If you are completing the application by hand, please do it very neatly and legibly, from the envelope right to the very last page. Remember you are trying to impress those judging it so make the task as easy as possible for them.

Write a cover letter, even if it isn't asked for. When you do, make sure you have addressed it properly. If you are unsure, call the pertinent office and ask. Make your cover letter your own. The samples you will google on the Internet will help you to formulate it but ultimately, yours should come from the heart. Be respectful and assertive, confident and earnest but not boastful.

It's a small thing but...sign your application with a legible signature. You always want to do your best to connect with the ones who are reading your application. A signature of unreadable squiggles and flourishes may be appropriate when you have reached your career goals but for now, keep it simple.

If your application is successful, write a thank you letter. There is an old saying: "Plant trees as you go through the desert as you may need the shade upon your return."

In closing, determining the recipient of any award is always hard and based on many factors. If you did everything right and were not chosen for an award, although it's disheartening, don't let it discourage you from researching and sourcing out all avenues

available to you. Keep trying.

If your coverage is elsewhere, we will do our best to provide contact information that will assist you.

If you are a Member of the Plans, we have recently mailed out new Plan Booklets for both the Benefit Plan and Pension Plan.

The Booklets are designed to provide a summary of Plan provisions. The Booklets are printed in a size that we hope is convenient for you to keep on hand. As always, we encourage you to contact our office if you have questions or require details on any aspect of the Plans.

Those of us who work at the Plans' office take great pride in being available to answer our Members' questions. It is unusual for Members to have to leave voicemail messages but when this is necessary, it is always our practice to return the call that day.

#### Teamsters' National Benefit Plan

#### When your Address Changes



There continues to be some confusion over how Change of Address information is communicated to the Plans. Please note, if you advise your employer that your address has changed, the information is not forwarded to the Benefit Plan or the Pension Plan.

If you have a change of address you should advise the following:

- 1. Your employer
- 2. The Benefit Plan and Pension Plan - 604-552-2650 Toll free 1-888-478-8111
- 3. The office of Teamsters Local Union No. 31 - 604-527-2702 Toll free 1-877-562-2531

These steps will ensure that <u>all</u> <u>offices</u> are updated and you won't miss critical information that is mailed to you.

Please note if your mailing address is a Box number, the Benefit and Pension Plan also requires a residential address.

The Plan will be sending out the 2015 Benefit Plan and Pension Plan T4A's in February 2016. As such, it is very important we have your current contact information on file.

## **Updated Beneficiary Designation Forms**

Do you know who you have named as the Beneficiary on your Group Life and Accidental Death and Dismemberment (AD&D) Insurance provided through the Benefit Plan?

Please ensure that this <u>very</u> <u>important form</u> is reviewed and updated if necessary. This document may be considered as part of your estate planning and should be reviewed periodically.

#### **Dependent Coverage**



The rules regarding who qualifies as a "Dependent" under the Plan can sometimes be confusing. To help we thought we should provide the following definitions:

"Dependent" means a person who is not a Member but who resides with a Member and who is:

a Spouse, or

an unmarried Child of a Member or of the Member's Spouse under the age of 19 years provided such Child relies principally upon the Member for support, or

an unmarried Child of a Member or of the Member's Spouse under the age of 25 years provided the Child is in full-time attendance at a recognized school, college or university and relies principally upon the Member for support, or

an unmarried Child of a Member or of the Member's Spouse of any age who is mentally or physically handicapped to the extent that he / she is incapable of self- support, provided such Child relies principally upon the Member for support.

Notwithstanding anything to the contrary in this sub-paragraph, in the event that a Member is legally separated or divorced and has been ordered by the courts to provide coverage for his / her dependents, Dependent shall include:

- any Child who resides with his former Spouse and meets all other conditions of being a Dependent, and
- a former Spouse, provided however the former Spouse shall only be covered in the event the Member has not appointed another Spouse

#### Teamsters' National Pension Plan (the "Plan")

## The Pension Plan's Role in your Future



As you know the Pension Plan was established in 1982 to be a supplement to other forms of retirement income. These forms would include government pensions and one's own Registered Retirement Saving Plans. The goal is to use these sources along with your Pension from the Plan to maintain a financially sound retirement.

All pensions from the Plan are payable for the Member's lifetime. In the case of a "Joint and Survivor' pension, the monthly pension continues for the life of the spouse if he or she is living at the time of the Member's passing.

#### **Pension Plan Booklets**

As noted earlier, Plan Booklets are currently being updated and should be distributed in the near future.

#### **Pension Plan Beneficiaries**

It is important to note that the beneficiary you have named for the Group Life and AD&D policies under the Benefit Plan does not apply to the Pension Plan. The two Plans are administered under separate Trust Agreements.

The Pension Plan is registered under the BC Pension Standards Act. This Act provides protection for the Spouses of Members of pension plans. As such, your

Spouse is automatically your beneficiary if you pass away prior to receiving a monthly pension from the Plan. This is called a "pre-retirement" death benefit.

If you do not have a Spouse, the pre-retirement death benefit is payable to the beneficiary you have named. Again, we remind you that this is totally separate from the beneficiary you have named on the Benefit Plan.

If you do not have a Spouse and have not named a Pension Plan beneficiary, the pre-retirement death benefit would be payable to your estate.

#### Eligibility for Pension Plan Membership



Eligibility and probationary periods for Pension Plan membership is determined through the provisions of your collective agreement. Once you are a Member of the Pension Plan, it is very important to review your annual Pension Statements to ensure that the pension hours being reported by your employer match your own records.

If you are in receipt of Worksafe BC benefits you should ensure that the Pension Plan is aware of your disability status as you are entitled to "non-work" (disability) accrual on your Pension record

#### **Pension Workshops**



The next Pension Workshops are tentatively scheduled for March 2016. The workshops are held at the Plan's office in Port Coquitlam and at the Teamsters Local 31 office on Mill Lake Road in Abbotsford.

Please watch the website for the March 2016 dates which will be posted shortly. The dates and times can also be provided by our office.

As always, we encourage you to contact our office if you require information regarding your individual pension with the Plan or other pension related matters. Also, if you have the time, we are more than happy to meet with you at the Plan's office.
