NOTICE TO ALL TEAMSTER LOCAL 31 SCHOOL DISTRICT No. 34 SUPPORT STAFF UPDATED FACTS ABOUT THE BCTF JOB ACTION

August 28, 2014

Teamster Local 31 would like to apologize for the confusion that has stemmed from the teachers' picketing practices. Information is being received by the Union from the ADTA but unfortunately the reported directions being given to the teacher pickets by the ADTA and what is actually being done are two different things. The Union was informed by ADTA that the teachers' pickets would go up at first bell at each school for a maximum of three hours. However what he could not tell us was which school would be affected or how many. I have a number of school sites reporting that in fact pickets are going up as soon as 6:45 am and in some instances remaining for the entire day. The conflict within the teachers' picketing practices makes it extremely difficult to relate with any certainty to the Teamster membership.

I would like to give a special thanks to Pres. Stan Hennessy who has been in continuous contact with ADTA in attempt to find a resolve for the Teamster members.

I have also been working with the District who has been very open in looking for alternatives and options for support staff who may be unable to enter their worksites should the teachers' strike continue in September.

I would like to remind everyone that if you arrive at your worksite and there are no pickets you may enter to work. If pickets are erected while you are inside you are to leave your worksite and may return when the pickets leave to complete your shift. The hour(s) lost will be compensated by the Teamsters Union at a rate of \$25.00/day for each workday interruption (leaving and returning).

I would also like to remind the membership that Sept 4th is the Abbotsford Gen Membership meeting at the ADTA Hall at both 1:00pm and 6:30pm
