Clarification of Sept 2/14 Notice to Teamster Employees – SD34

I have been informed that the notice of September 2, 2014 on the Teamster Website was not clear to a number of membership. I shall therefore try to be more succinct.

SEPTEMBER 5, 2014 ONLY – NO PICKETS – ALL EMPLOYEES TO REPORT TO WORK

DAY SHIFT EMPLOYEES (Clerical/Instructional Support)

President Hennessy and Pres. Smuland (ADTA) spoke at great length yesterday in an attempt to reach an amicable strategy for teacher pickets (rotating pickets, etc.) The teaching staff expressed that they did not wish to entertain any form of picketing other than their required 3 hour shift per day. That being the case the Teamsters were left with no other option but to inform the Teamster membership that all members on “day shift” that are not in an exempt site should not report to work and will be compensated by the Teamsters as they were in June, 2014, \$70.00 per day for a full shift. Those on half shift would receive half of the “lost wages” amount. Teamsters Canada and Local 31 have committed to this for the duration of the teacher strike.

The School District has organized “training sessions” for both clerical and EA staff. Should you wish to take part in these sessions you may do so as they will not be offered on picketed sites. If you do attend a half day session your “lost wages” compensation would be for a half day (\$35.00).

AFTERNOON SHIFT EMPLOYEES (Custodial)

As the teaching staff will commit only to a 3 hour strike action (8am – 11am) the School District sites will not be under pickets for the afternoon shift. Teamster afternoon shift employees will not be facing picket lines and may therefore enter their worksites unobstructed.

Should there be changes to the above directions, Teamster members will be advised as quickly as possible.
